NOTES:-(i) Shab-E-Barat*-May 12, Last Friday of Ramzan – June 23, Rakshabandhan – Aug. 7, Kalash Sthapana – September 21 are Restricted Holidays. An employee can avail maximum of two Restricted Holidays in a calendar year. However prior permission of the Officer authorised for granting Casual Leaves is essential. These leaves can be granted keeping in mind the requirement of the court.

- (ii) There will be vacation court during the summer vacation. The officers and employees can be granted only 10 days vacation leave during this period.
- (iii) The office may remain open on one or other day during the Puja and Christmas Holidays, as may be ordered by the Hon'ble Chairperson.

*These are tentative dates which may be changed by Hon'ble Chairperson according to the visibility of the moon.
